<u>ORIGIN</u>

November 28, 2023 Budget Committee (Item 6.2):

THAT Budget Committee:

1. Direct the Chief Administrative Officer to develop the 2024/25 Budget according to Council's approved priorities; and,

2. Approve revised debt policy of \$1,800 per dwelling.

MOTION PUT AND PASSED.

LEGISLATIVE AUTHORITY

Pursuant to the Halifax Charter:

Section 35(1) The Chief Administrative Officer shall (b) ensure that the annual operating and capital budgets are prepared and submitted to the Council

Section 79A (1) Subject to subsections (2) to (4), the Municipality may only spend money for municipal purposes if

(a) the expenditure is included in the Municipality's operating budget or capital budget or is otherwise authorized by the Municipality;

(b) the expenditure is in respect of an emergency under the Emergency Management Act; or

(c) the expenditure is legally required to be paid.

RECOMMENDATION

It is recommended that Budget Committee recommend Halifax Regional Council to approve the schedule of 2024/25 advanced tender requests as per Attachment 1.

BACKGROUND

In preparation for updating the capital plan for the 2024/25 budget, a progress update is provided to Budget Committee on previously approved projects, as well as an overview of the key drivers being considered for proposed capital investments.

DISCUSSION


Annually, the capital budget process begins by updating project assumptions on the existing ten-year capital plan. Using a standardized prioritization process to guide decisions for project timelines and value of each proposed investment, the portfolio is adjusted within the available funding envelope as defined by Council's direction for external cost-sharing agreements, debt policy, reserve business cases, and annual tax levels.

Currently staff are developing a new, Social Equity lens, to add to project evaluations in the Capital Prioritization Framework. Beginning in the capital plan update process for 2025/26, projects will be assessed for their value and impact to:

- Risk,
- Impact to Service,
- Strategic Alignment,
- Social Equity, and
- Capacity to Deliver.

Based on the status of the existing capital projects in-progress, staff assess overall capacity to take on new work. Historic high inflation, labour market shortages and supply chain delays in materials since the global pandemic have caused projects to be both rescoped and delayed. Where project budgets have not increased to mitigate tax increases, less asset rehabilitation work has been completed. Staff continue to adjust work plans as a result of these continuing economic drivers.

Further detail by individual project of the information presented in Figure 1 can be found in Attachment 2 of this report.





In 2022/23 a doubling of the annual capital program for HRM occurred in response to significant and transformative planning strategies affecting infrastructure. Capital investments identified in the Integrated Mobility Plan, HalifACT Climate Action Plan, and 2014's Planned and Potential Strategic Capital report are included in the Strategic Initiatives Program, which require funding above the municipality's historic investment levels to maintain existing infrastructure and service levels. The Climate Action Tax and Strategic Initiatives Reserve annual tax contributions, along with use of debt funding outside historic debt policy goals aim to alleviate the short-term tax bill impact. Reductions in the short-term of these tax contributions to the Reserve will compound the tax burden in future years.

Also impacting the capital growth program was Council's direction in setting Level of Service for the HRM Street Network (<u>Halifax Regional Council, Item No. 15.1.5</u>, January 25, 2022), which established targets for the assessed condition of municipal roads therefore driving an investment increase to meet expected standards in the ten-year plan. Since this direction, Council has approved an \$8M reduction in this project budget to mitigate the tax burden. Budget Committee was presented an option to further decrease annual taxes in the 2024/25 capital budget by \$30M at the <u>November 28, 2023 Budget Direction meeting</u>, from the approved capital guidelines set in 2022/23 to adequately fund infrastructure pressures to mitigate the risk of aging assets, service capacity constraints, and avoiding higher long-term costs of deferred maintenance.

The large growth of the annual capital program at a time of industry labour shortages and other challenges, has resulted in less project delivery than was budgeted the last two years. Staff have spent considerable time revising the 2024/25 work plans to match delivery expectations to current capacity.

The biggest challenge ahead facing the municipality is the immediate pressure of the significant population growth. In addition to development needs in high growth areas, existing services are experiencing capacity issues, greater pace of wear and tear, and new programming. Infrastructure project delivery is not generally nimble enough to respond quickly to these unplanned changes.

The advanced tender list of project requests is put forward for Council's approval each December to assist with the front-end administrative work to tender key work which is dependent on maximizing seasonal construction. In addition, this year there are some projects which are looking to leverage additional lead time to mitigate known significant supply chain delays.

Next Steps:

Regional Council will receive the 2024/25 Draft Capital Plan book, containing the details of every project proposed for the four-year capital plan for their review on December 13, 2023. This will allow a month for Council's review before staff return to present the capital budget recommendation to Budget Committee on January 24, 2024.

FINANCIAL IMPLICATIONS

Approval of the Advanced Tender schedule in Attachment 1 provides the authority for project managers to engage in procurement activities to begin execution on \$107,370,000, or 27% of the proposed 2024/25 capital budget which will be recommended for approval on January 24, 2024. Over the past five fiscal years, the average Advanced Tender total request equated to 35% on average of the total capital budget. Therefore the 2024/25 is a reasonable level compared to past practice.

RISK CONSIDERATION

Advanced Tender requests are intended to mitigate seasonal weather risk to begin the upfront administrative tendering process of construction work to maximize the most days available for executing project plans. The risk to Council in approving 27% of the 2024/25 capital budget to begin early is minimal due to its small portion of the overall expected authority to spend, and that 22 out of the 26 requested projects are ongoing annual programs in nature.

COMMUNITY ENGAGEMENT

No community engagement was required. The most recent Municipal Services Survey was conducted in September 2022 while the most recent Resident Survey results were made available to Regional Council through an information report provided on November 23, 2021.

The 2024/25 budget consultation process seeks to solicit public comment by inviting members of the public to provide feedback following each public budget and business plan presentation.

ENVIRONMENTAL IMPLICATIONS

Any environmental implications associated with a particular capital project are assessed during project planning and management.

ALTERNATIVES

Budget Committee could choose to:

- 1. Alter any of the projects and/or amounts contained in Attachment 1, or
- 2. Not approve the recommendation.
