Crysta Cumming, Manager, Engineering Design gave a presentation, seeking feedback on the Temporary Pedestrian Travel Paths Through Work Sites report and responded to question of clarification from the Committee.

- Concerns with temporary pedestrian walkways that required frequent street crossings;
- Lack of accessible pathways on certain construction sites;
- The effects of construction sites on nearby accessible parking spaces;
- Specific challenges encountered by residents who are visually impaired and/or wheelchair users on construction sites;
- Barricade placements;
- The need for certain standards to be enforced on sites;
- Safey issues with uneven surfaces and platforms;
- Accessibility challenges in relation to signage placement; and
- Challenges faced by those with colour blindness.

Maria Jacobs, Active Transportation Planner, Courtney Pyne, Team Lead – Senior Traffic & Transportation Engineer, WSP Canada and Brianna Rietzel, Transportation Engineer-in-Training, WSP Canada gave a presentation, seeking feedback on the proposed designs and responded to questions of clarification from the Committee.

The Committee noted the following:

- Preferred structures used to separate walkways from arterials roadways;
- The need to balance traffic congestion with active transportation needs;
- Concerns with lane reductions;
- The importance of prioritizing dedicated bus lanes;
- The needs of diverse modes of transportation;
- Benefits of separating walkways and bikeways; and
- Concerns regarding multi-use pathways, particularly in high traffic areas.

Matthew Glynn, Project Manager, Facility Renewal, Alana O'Halloran, Associate, Arcadis and Charlie Haong, Transit Architecture Lead, Arcadis gave a presentation, seeking feedback on the proposed terminal design and responded to questions of clarification from the Committee.

The Committee noted the following:

- The possibility of providing additional seating in the designated bays;
- Ensuring text was legible on screens displaying bus schedules;
- The potential for cigarettes butts to be left in the planters;
- The need for designated pick up and drop off areas;
- The sounds and echoes created by glass buildings and subsequent impacts on neurodivergent individuals; and
- The possibility of installing acoustic panelling to offset sound.
