- 9.1.1 Point Pleasant Park Operations Update

The following was before the Committee:

Adam Cornick, Superintendent Parks West spoke to the staff memorandum and responded to questions of clarification from the Committee regarding painting the parking lots, direction lines of the park, and the possibility of addressing tents found in the park.

9.1.2 Point Pleasant Park Advisory Community Mandate

Adam Cornick, Superintendent Parks West spoke to the Point Pleasant Park Advisory Community's mandate, which was to ensure the Municipality followed the Point Pleasant Park Comprehensive Plan which served as guidelines and recommendations for long-term planning of the Park. Cornick responded to questions of clarification from the Committee respecting the potential designated encampment site in the Park, noting that the Committee was not by-passed, as the decision to recommend potential site locations was made at the director level across several Business Units. Cornick added that the potential list of encampment locations was needed for a short-term solution to a significant problem in Halifax which would not have an impact on the long-term overview of the Park's Comprehensive Plan.
