Andrew Gough, Solicitor proposed the motion be amended to replace 'direct' with 'recommend' as the Board did not have jurisdiction to direct the Chief Officer.

Deputy Chief Matthews clarified that files would be selected at random and forwarded to the Board.

Chief Don MacLean, Halifax Regional Police (HRP) advised they had no concern with the word 'direct' as the motion spoke to HRP participating in the review and did not provide operational directive to review a specific case/file.
