Ronan Grey, Planner I gave a presentation and responded to questions of clarification from Community Council.

The Chair reviewed the rules of procedure for variance hearings, opened the hearing, and invited the property owner to come forward and address Community Council.

Kristen Lewis, Archadeck of Nova Scotia gave a presentation, speaking on behalf of the property owners, Aine Humble and Arthur McCalla, on the necessity of the deck replacement due to its age. Lewis highlighted that the property was within the six-metre rear setback requirement and that due to the above grade rear door, a deck under 40 inches would not be feasible. They added that a deck was required to ensure the property owners had access to the rear door. Lewis emphasized that the proposed deck would not change the scale and character of the neighbourhood and asked Community Council to consider the property owner's request.

The Chair invited property owners within the notification area to speak regarding the appeal; there were none.

The Chair called three times for any other speakers within the notification area to come forward and address Community Council; there were none.
