The meeting was called to order at 6:01 p.m. and adjourned at 7:45 p.m.

1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Savage called the meeting to order at 6:01 p.m. and acknowledged that the meeting took place in the traditional and ancestral territory of the Mi'kmaq people, and that we are all treaty people.

12. PUBLIC HEARINGS 12.1 Property Matter – Africville Heritage Trust

The following was before Council:

Rudy Vodicka, Project Manager, Corporate Real Estate gave a presentation and responded to questions of clarification from Regional Council.

The hearing opened at 6:15 p.m.

Mayor Savage invited the applicant to come forward and address Council.

Percy Paris, Applicant spoke to the parcels of land and the future development of the land. Paris added that the Africville Heritage Trust (AHT) requires the land to boost tourism in Africville as the site is rich in historical value. They highlighted that the two parcels of land would provide parking space for tour buses. They spoke on the history of Africville and that the AHT's goal was to ensure the community reaches its full potential. Paris emphasized that the former residents and descendants of Africville continue to experience the effects of the history of the community. They highlighted that investment in Africville would

benefit the tourism industry and encouraged Council to continue to invest in Africville. They thanked staff for their cooperation, effort and understanding during the process. Paris responded to questions of clarification from Regional Council.

Mayor Savage reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

Eddie Carvery Sr., Africville spoke to being a resident of Africville and their activism against the displacement of Africville residents. Carvery Sr. emphasized the effects of the displacement and racism of Africville residents and the continued impacts of the displacement. They highlighted that they had not been consulted regarding the sale of land which is their current home. Carvery Sr. added that there was no compensation awarded to former residents or descendants for their loss. They stressed that the residents of Africville should control their own communities and self-develop the community.

Eddie Carvery III, **Africville** spoke to the noninvolvement of the Africville community in the decisionmaking processes of AHT. Carvery III highlighted the divide in the Africville community and that the intentions of AHT do not represent all the voices of the community. They questioned the capacity of AHT to preserve and develop the land. Carvery III added that the Africville residents continue to deal with alcohol abuse, crime related activities and drug abuse which result from their noninvolvement in the redevelopment of the community. They advised Council to pause the land acquisition until the Africville revisioning process was complete. Carvery III responded to questions of clarification from Regional Council.

Beatrice Wilkins, Africville spoke to the goals of the AHT for the land acquisition to expand parking, grow the marina, sustain the museum and establish an interpretive centre. Wilkins highlighted that the visioning process should begin with consultations with the former residents of Africville. They added that the acquisition of the land would grow the community of Africville and encouraged Council to approve the sale to ensure the Africville museum continues to be self-sustainable.

Bernice Byres-Arsenault, Africville spoke to the displacement of former residents and descendants of Africville. Byers-Arsenault noted that if the land was used for public housing, the Africville community would not be able to afford the housing. They emphasized that Africville is a historical site and that the parcel of land would provide sustainability. Byers-Arsenault responded to questions of clarification from Regional Council.

Mayor Savage invited the applicant to respond to questions raised by the public.

Percy Paris responded to questions raised by the public. They spoke to the declaration of Africville as a national historic site by the Federal government. Paris added that the acquisition of the land would provide AHT with the authority and flexibility as owners of the land. They emphasized that further due diligence was required for future developments. Paris responded to questions of clarification from Regional Council.
